
SHARES TRANSFER BETWEEN SUBSIDIARY COMPANIES

The Board of Directors of Top Global Limited (the “Company”) and together with its subsidiaries (the “Group”), wishes to announce that pursuant to share transfer between the subsidiaries within the Group, Entro Development Pte. Ltd., a wholly-owned subsidiary of Top Global Properties Pte. Ltd., has transferred 2 shares, representing 100% equity interest in Cerapure Pte. Ltd. (“Cerapure”) to Top Global Hospitality Pte. Ltd. (“TGH”), a wholly-owned subsidiary of the Company for a total consideration of SGD2.00 (the “Consideration”).

The Consideration was satisfied in cash and arrived at on a willing-buyer willing-seller basis, after taking into consideration, inter alia, that this is a share transfer to another subsidiary of the Group.

As a result of the transfer, TGH holds directly 100% equity interest in Cerapure and Cerapure becomes a wholly-owned subsidiary of TGH.

The above transactions are funded through internal resources and are not expected to have any material effect on the earnings per share or net tangible assets per share of the Group for the financial year ending 31 December 2018.

No director or substantial shareholder of the Company has an interest, direct or indirect, in the above transactions (other than through their respective shareholdings in the Company).
